SCSD WELCOMED 65 NEW OFFICERS IN 2025

This past year, the Suffolk County Sheriff's Department marked a significant milestone with the swearing-in of sixty-five new Correction Officers (COs), each committed to upholding the Department's mission and vision. These officers have answered the call to serve with integrity and professionalism, ensuring the proper care and custody of those entrusted to us while maintaining order and operational excellence inside our facilities.

Before earning their badges, each officer candidate successfully completed our rigorous Training Academy, a comprehensive twelve-week program designed to prepare them for the responsibilities inside a correctional setting. The academy curriculum blends classroom instruction with physical training, equipping cadets with both the knowledge and resilience required for the role. Candidates received in-depth education on state ethics laws, inmate rights and responsibilities, emergency response planning, gang awareness, hostage situations, fire safety, radio procedures, report writing, trauma-informed corrections, and security protocols, including key control and inspections.

Alongside these academic components, cadets are trained weekly in defensive tactics, use-of-force principles, and physical resistance, guided by our professional training instructors. The educational section of the academy further reinforced the foundation of public service, studying the elements of the Criminal Justice System, ethics and accountability, courtroom testimony, Criminal Offender Record Information (CORI), and more. Together, these lessons helped develop technical proficiency, sound judgment, integrity, and mental readiness for the challenges officers may encounter.

In addition to physical and mental preparation, every candidate received certification in Cardiopulmonary Resuscitation (CPR). This training remains a critical component of our commitment to safety and care, as it has played a vital role in saving lives during medical emergencies within our facilities.

The successful completion of each training program is formally recognized during a graduation ceremony held at Casa Lucia, hosted by our Department for our officer candidates and their families. In each ceremony, Sher-

iff Steven W. Tompkins administers the oath, officially swearing in the new officers into the Department. Speeches from instructors and class presidents are also presented. Each ceremony also celebrates outstanding achievements, with awards and recognitions presented to officers who demonstrated exceptional performance throughout their training in the Academy.

Congratulations to all sixty-five graduates of classes of Correction Officer Training Academy (COTA) 25-01, 25-02, and 25-03! As Assistant Deputy Superintendent (ADS) Jessica Cabrera-Edwards aptly stated before, "Beyond the uniform, the badge, and the imposing walls of a correctional facility lies a profession that demands an extraordinary blend of strength, intellect, and humanity. To be a Suffolk County Correction Officer takes unwavering resolve and mental fortitude, exceptional communication and observation skills, impeccable integrity and professionalism, physical fitness and situational awareness, empathy balanced with firmness, and a commitment to public service." ~ADS Cabrera-Edwards

SUMMER ENRICHMENT PROGRAM 2025

MARKS ITS 11TH RUN

The 2025 Summer Enrichment Program (SEP) cohort concluded its 11th cycle with sixteen driven graduates, marked by experiential and holistic learning. Led by Sergeant Stacey Wood and Community Outreach and Youth Programs Coordinator Lucretia Goodson, and Roxbury Community College Director of Programs and Community Outreach Janelle Ridley, the program was supported by a dedicated team, including Officer Estherline William and Administrative Assistant Stephona Wilson-Singleton, whose guidance helped shape a summer experience unlike years past.

Over the course of the program, high-achieving students from Revere, Winthrop, and Boston explored the breadth of public safety and law enforcement, engaging in leadership training, financial literacy, street law, and Mind Boost cognitive development classes. This summer, classes were taught by esteemed community leaders such as Gary Bracey, State Representative Russell E. Holmes, and former U.S. Attorney Rachael Rollins.

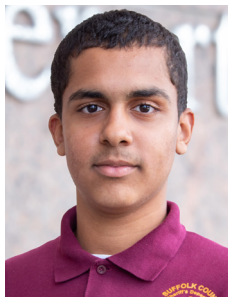
Participants visited some of the region's most notable institutions, gaining firsthand insights from professionals across the field. Highlights included the Federal Bureau of Investigation Headquarters, Hanscom Air Force Base, Massachusetts State Police, Revere Fire and Police Departments, Winthrop Harbormaster Department, Suffolk County District Attorney's Office, and Tufts University Police Department. Within the Sheriff's Department itself, students were trained in CPR, defensive tactics, and first-responder readiness while exploring innovative solutions to ongoing community challenges.

The 2025 program also introduced a new approach to the traditional capstone project, allowing students to translate their learning into interactive board games. From "Crimenopoly" to "Heart2Heart," the cohort combined research, creativity, and problem-solving to explore topics like Artificial Intelligence (AI) in public safety, mental health resources, and substance use education. Presented at the August 22nd graduation ceremony at Roxbury Community College's Reggie Lewis Center, the games turned abstract concepts into tangible, engaging experiences, demonstrating the power of active and experiential learning.

As the 2025 SEP students advance in their future law enforcement, military, legal, and other careers, they carry with them lessons in resilience, critical thinking, and civic engagement, equipped with the confidence to apply them in real-world settings. The Suffolk County Sheriff's Department congratulates its cohort and thanks all staff, mentors, and community partners whose dedication continues to inspire the next generation of leaders.

SCSD'S YOUTH PROGRAM INITIATIVES CONTINUE ACROSS SUFFOLK COUNTY

This year, twenty-one Suffolk County officers stepped into classrooms with one goal: to inspire students before life's challenges turn into lasting consequences. After completing an intensive three-day training at the Correction Officer Training Center in May, these officers are now certified Choice Program Officers, prepared to deliver lessons on digital literacy, personal responsibility, emergency preparedness, Criminal Offender Record Information (CORI) reports, and more to K-12 students across Suffolk County.

Led by ADS Jessica Cabrera-Edwards and Captain Deniqua Lopes, the training combined practical public speaking skills with mentorship strategies. Officers explored bullying, peer pressure, sexting, gun violence, substance use, and active shooter protocols. They also learned from seasoned guest instructors, including Sgt. Detective Janine Busby and Officer Alexander Reyes of the Boston Police Department's School Engagement Unit, Courtney Grey from the Boston Public Health Commission, and Jacquelyn Lamont of the Suffolk County District Attorney's Children's Advocacy Center. Mock classroom presentations gave officers a chance to practice delivering age-appropriate, engaging lessons, preparing them to connect with students as mentors and role models.



Following this choice-driven model to disrupt the school-to-prison pipeline, the JailBrake program was brought back this Fall to reach at-risk youth between the ages of 12 and 16. Participants engage in a guided, educational glimpse into life behind bars, meeting jail staff, caseworkers, and detainees while learning firsthand about the consequences of arrests and convictions. Beyond the tours, students are connected with legal and emotional support resources to help them make informed choices that can redirect their path toward opportunity and success.

Together, Choice and JailBrake are equipping young people with the tools to navigate through life safely. By addressing challenges at the onset, these programs are working to break cycles that have led too many down a path of loss, proving that preventative engagement can influence trajectories.

SCSD'S TRANSFORMATIVE MEN AND WOMEN PROGRAMMING:

As our readers already know, the Suffolk County Sheriff's Department is committed to providing programs and services that extend beyond the scope of traditional correctional care. Guided by the vision of improving the lives of both our male and female residents alike, the Department places a strong emphasis on rehabilitation, personal development, and successful reintegration into the community. Our comprehensive programming includes adult basic education, vocational training, substance use & harm reduction programs, religious and reentry services, and pre-release initiatives, all thoughtfully designed to empower, heal, educate, and uplift those in our care.

Addressing the individual needs of our residents is essential to achieving meaningful and lasting change. This commitment is reflected in the continuous development of programs that foster accountability, skill-building, and personal transformation, helping residents prepare for a productive and positive future.

Over the past year, we celebrated graduations from several programs and the launch of new initiatives for both men and women. These milestones represent significant progress for our residents and underscore the Department's dedication to innovation and advancement. Below, you will find a timeline featuring last year's highlights.

MEDICATION-ASSISTED TREATMENT (MAT) *A Service Offered to all Residents* **March 2025**

Our Medication-Assisted Treatment (MAT) program provides lifesaving care for individuals struggling with substance use disorder through a comprehensive, strength-based approach. By combining Federal Drug Administration (FDA)-approved medications, education, and coordinated support, MAT helps stabilize health, reduce overdose risk, and prepare participants for successful reentry into the community, offering hope, continuity of care, and a pathway toward long-term recovery.

NURTURING FATHERS CLASS GRADUATION *A Service Offered to all Male Residents* **March 2025**

Our Nurturing Fathers program is a 10-week reentry initiative that helps incarcerated fathers heal from past trauma, strengthen emotional stability, and rebuild meaningful connections with their children. Led by experienced facilitators from the Family Nurturing Center, the program goes beyond parenting skills to address accountability, personal growth, and breaking cycles of generational harm. Through reflection, family engagement, and a powerful graduation ceremony shared with loved ones, participants leave committed to becoming present, responsible fathers and returning to their families with renewed purpose and hope.

FATHERS' UPLIFT CLASS GRADUATION *A Service Offered to Male Residents* **March 2025**

Fathers' Uplift is a transformative 10-week program designed to help incarcerated fathers rebuild their lives, strengthen family bonds, and embrace responsible, sober parenthood. Through guided self-reflection, mentorship, and practical parenting education, the Nurturing Fathers curriculum equips participants with the tools to take accountability, heal relationships, and prepare for successful reentry.

ART PROGRAM *A Service Offered to All Residents* **July 2025**

Our Arts Program offers residents at the House of Correction (HOC) a powerful outlet for healing, self-expression, and personal growth. Through hands-on instruction in painting, drawing, sculpture, and mixed media, participants are guided to explore creativity as a therapeutic tool to process trauma, manage stress, and rebuild confidence.

The program also helps residents reconnect with themselves, envision a positive future, and take meaningful steps toward rehabilitation and reentry.

WOMEN'S EMPOWERMENT GROUP

A Service Offered to Female Residents

July 2025

The Women's Empowerment Group is a six-week initiative designed to support incarcerated women through self-discovery and personal growth. Led by formerly incarcerated sisters Angelia Jefferson and Chiteara Thomas, the program offers a curriculum focused on self-worth, resilience, healthy relationships, life skills, and future planning. Rooted in lived experience, empathy, and authenticity, the group provides a safe space where women feel seen, heard, and supported.

RADICAL REVERSAL, MUSIC PROGRAM

A Service Offered to Male Residents

September 2025

Through an ongoing partnership with Radical Reversal and our Department, our "Positive Energy Always Creates Elevation" (PEACE) Unit residents enjoy a creative outlet centered on music composition and writing. Led by professional artists and educators, the program uses songwriting and recording workshops to help participants express their experiences, build emotional awareness, and develop positive coping skills.

ART THERAPY

A Service Offered to Male Detainees

October 2025

At the Suffolk County Jail, a new Art Therapy Initiative offers detainees a creative outlet for healing, reflection, and personal growth. Led by caseworker Shawnte Walls, the program combines painting, journaling, scrapbooking, and affirmations with open group discussions, helping participants build self-esteem, emotional awareness, and confidence.

Through these expressive activities, detainees engage in meaningful reflection while developing tools to support rehabilitation and successful reentry into the community.

"LOCKED IN" PODCAST PROGRAM

A Service Offered to Male Residents

August 2025

The Department's new Podcast Program called "LOCKED IN" is a six-week initiative that was launched last year at the House of Correction, which empowers incarcerated individuals to build confidence, creativity, and job-ready digital media skills. Through hands-on training in podcast production and storytelling, participants learn to share their voices, strengthen communication, and prepare for future opportunities in media and beyond.

"LOCKED IN" PODCAST PROGRAM

A Service Offered to Female Residents

October 2025

Our "Locked In" podcast program expanded its service to female residents, offering them hands-on training in podcast production while fostering creativity and self-expression. Meeting twice a week, the class teaches technical skills like camera operation and editing while providing a supportive space for storytelling, peer connection, and personal growth. Through the program, participants gain confidence, share their unique perspectives, and create podcast episodes that amplify their voices, providing a creative outlet and skills for the future.

NOBLE CONFERENCE: FIRST ANNUAL AWARDS CEREMONY:

During Black History Month 2025, Sheriff Steven W. Tompkins was honored with NOBLE Massachusetts' inaugural "Living Legend" Award for his decades of leadership, advocacy, and impact in law enforcement and criminal justice reform. Joined by Department staff, the ceremony celebrated excellence across several categories, highlighting Sheriff Tompkins' lasting influence and his role in inspiring the next generation of Black law enforcement professionals.



SCSD HONORED BY TOYS FOR TOTS DRIVE:

Members of the Suffolk County Sheriff's Department were recognized by the U.S. Marine Corps' Greater Boston Chapter for their commitment to the 2024 Toys for Tots drive, helping bring joy to children and families across Suffolk County. Honored at an awards banquet in Quincy, the evening celebrated collaboration among law enforcement, fire rescue teams, and community leaders, highlighting shared dedication to service, generosity, and community impact.



LLEGO BOWLING TOURNAMENT FOR WOMEN'S HISTORY MONTH (WHM):

The Suffolk Sheriff Phantoms, also known as "Amo a Loíza," proudly returned as champions after winning first place at the Latino Law Enforcement Group of Boston's Annual Women's History Month (WHM) Bowling Tournament. Led by Special Sheriff Abiezer Ayuso, the team earned a \$1,500 grand prize and chose to donate their winnings to Casa Myrna, a Boston nonprofit supporting survivors of domestic violence. This victory highlighted not only teamwork and perseverance but also the Department's continued commitment to giving back and uplifting the community.



SCSD GETS RECOGNITION BY REVERE CITY COUNCILOR:

On February 27, 2025, members of the North Metro Special Weapons and Tactics (SWAT) Team were awarded City Citations by Revere City Councilor Michele Kelly for their role in dismantling three major drug houses in Revere. Honored for their professionalism and precision, the team's high-risk operations led to the seizure of narcotics, firearms, and cash, significantly enhancing public safety. The Suffolk County Sheriff's Department proudly recognizes its dedication and exemplary service.



SCSD'S MARINE PATROL ASSIST IN RESCUE OPERATION:

On July 12th, the swift and coordinated response of the SCSD's Marine Patrol and the Winthrop Harbormaster's Office led to the successful rescue of two kayakers in distress off the Winthrop coast. Battling dense fog, high winds, and rough seas, Sergeant Dennis DeCarney, retired Captain Kevin Janielis, and Donald Lancelotte conducted a challenging search and rescue operation that safely located and recovered both individuals. Their professionalism, teamwork, and dedication to public safety exemplify the critical role SCSD's Marine Deputy Team plays in protecting lives on our waterways.

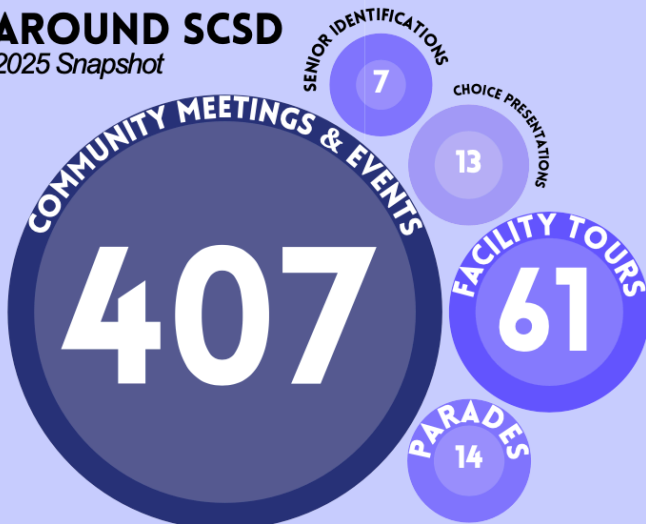

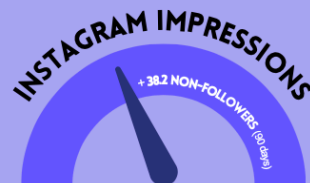

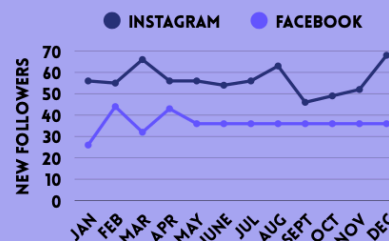

SCSD Continued Facility Tours, 2025

The Suffolk County Sheriff's Department offered 30 tours in our facilities to eligible schools and community organizations, where they're able to learn firsthand about corrections and public safety, fostering transparency and education.

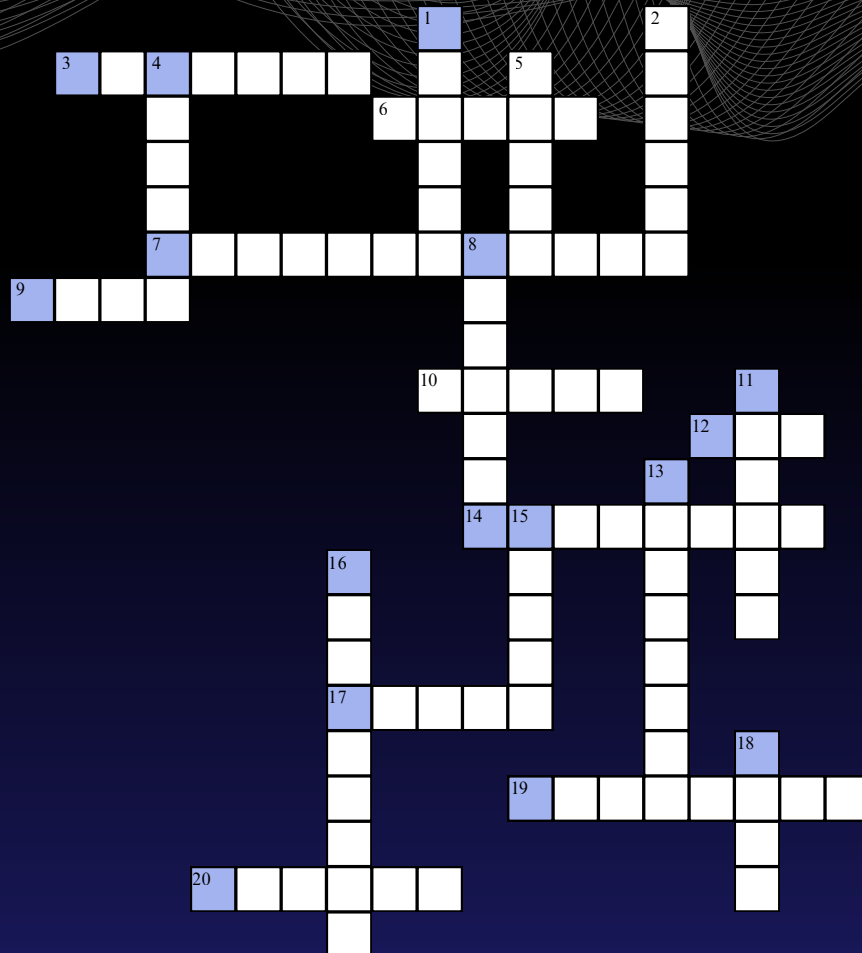


Shop With a Cop | December 2025
